The total number of occupied live poultry stalls in the public markets before the commencement of the voluntary surrender scheme in July 2004 is 449. The number of occupied live poultry market stalls as at end-February 2007 is 263. Please refer to Annex for details.

The Department will review the position in individual markets and consider the most beneficial use of these vacant stalls. The decision for each market may vary, having regard to the types of business being conducted and the internal environment in the market.
