### **Question:**

With regard to the work of "managing licensed hawker pitches, hawker permitted places and hawker bazaars", please provide information on the following:

- the location, name, year of commissioning, number of stalls that can be accommodated, current number of stalls and vacancy rate of each of the existing licensed hawker pitches, hawker permitted places and hawker bazaars in the territory, with a breakdown by district; and
- whether there are plans to close any of the hawker permitted places or hawker bazaars; if yes, the details and the estimated expenditure involved.

# Reply:

1. Information on the number of licensed on-street hawker pitches, number of vacant hawker pitches and relevant vacancy rates in the territory is provided at Annex I.

Information on the name, year of commencement, number of licensed hawker pitches, number of vacant hawker pitches and vacancy rate for each of the hawker permitted places and hawker bazaars in the territory are provided at Annexes II and III respectively.

2. The Food and Environmental Hygiene Department (the Department) has no plan to close any of the hawker permitted places. For hawker bazaars, the Department recognises that there is a need to formulate exit plans for bazaars with high vacancy rates to ensure that scarce land resources are released for redevelopment and put to gainful use. The Department will actively formulate improvement or exit plans for existing hawker bazaars, having regard to their business viability, the needs of the community, resource availability and competing priorities. In fact, the Department has closed Tai Lin Pai Road Cooked Food Hawker Bazaar in 2015, Yu Chau West Street Cooked Food Hawker Bazaar and Ma Kok Street Cooked Food Hawker Bazaar

in 2016, and is now planning to reprovision Yen Chow Street Temporary Hawker The Department will continue to explore whether the other hawker bazaars can be put to alternative uses. There is no breakdown on expenditure involved.
