### Reply:

Since 1 July 2015, the threshold of tenants' support for retrofitting air-conditioning facilities (A/C) in public markets has been lowered from 85% to 80%. The Food and Environmental Hygiene Department has completed the consultation with the Market Management Consultative Committees (MMCC) of public markets without A/C. The MMCCs of 27 of these markets supported conducting a questionnaire survey to collect the tenants' views on the retrofitting of A/C in the relevant public markets. The questionnaire surveys were subsequently conducted and completed. The results are tabulated at Annex I.

Following the Policy Address in October 2017, we have completed surveys to 4 markets at the latest requests of their MMCCs. The results are tabulated at Annex II.
