Reply:

The information sought is provided as follows -

- The Food and Environmental Hygiene Department (the Department) receives a.&b. environmental hygiene complaints from members of the public through multiple channels, including reports pinpointing locations with unsatisfactory hygiene The Department will conduct investigation and take measures to abate conditions. the nuisance. Depending on the circumstances prevailing at individual locations, the Department will adjust the frequency of street washing and pest control operations and step up enforcement action as appropriate. There is no hard and fast definition of what a hygienic "black spot" is; the term is used to refer to an area where the cleanliness problem remains obstinate despite enhanced cleansing. list of the top 5 locations in each of the 19 districts, as in March 2018, to which the Department devotes more efforts and resources in tackling the problem of illegal dumping of refuse is set out in Annex. The Department does not keep separate breakdown on the expenditure and manpower serving the locations identified as hygiene blackspots.
- c. The Department launched a six-month pilot scheme on installation of Internet Protocol (IP) cameras (the Pilot Scheme) in late December 2016, under which IP cameras were installed at a total of 6 illegal refuse dumping blackspots in Central and Western, Sham Shui Po and Yuen Long districts to step up surveillance on illegal dumping of refuse and to assist in the planning of more effective law enforcement actions. The actual expenditure of the Pilot Scheme was about \$1.04 million. The 6 illegal dumping blackspots are tabulated below -
