Question:

- (a) Please set out in tabular form the hawker bazaars and markets which are located at sites granted by way of temporary government land allocation and the year when they were first granted the site for such use.
- (b) Why were the sites first granted by way of temporary government land allocation but not permanent government land allocation?
- (c) Given their long-term existence, what is/are the reason(s) for not changing their temporary government land allocation status to permanent government land allocation status?

Reply:

- (a) The information sought is provided at Annexes I and II.
- It has been the Government's position since the early 1970s that out of (b) & (c) environmental hygiene considerations no new hawker licences should normally be issued and that on-street licensed hawkers should be resited into public market buildings or off-street hawker bazaars as far as practicable. To speed up the process and given the limited choice of suitable sites then, some of these markets or hawker bazaars were set up on sites granted by way of temporary government land allocation, and were designed to serve as a transitional arrangement. With a view to ensuring better utilisation of scarce land resources, the Food and Environmental Hygiene Department (the Department) will examine whether these sites should continue to be used for the present purpose having regard to the business viability of the facilities there, community needs, availability of resources as well as stakeholders' views. The Department will seek permanent land allocation in respect of the sites if there is a long-term need for them.
