Reply:

- (a) The information sought is at Annex I.
- (b) As an on-going initiative, the Food and Environmental Hygiene Department (the Department) has been taking forward measures to improve the operating environment of public markets, including improvement of ventilation, lighting systems and fire services, refurbishment of external walls, refurbishment of toilets, etc. as appropriate. From 2015-16 to 2017-18, the Department had carried out 28 improvement works projects in 24 markets as set out in Annex II.

In addition, to ensure the smooth operation of escalators and lifts in the public markets, we started in 2015-16 a programme to replace aged escalators and lifts in phases. To date, we have earmarked about \$300 million for the replacement of 87 escalators and 33 lifts in 26 markets. A list of the markets concerned is at Annex III. The replacement works are expected to be completed progressively in the coming years.
