- I. The number of licences surrendered and newly issued in each of the past 3 years, with a breakdown by hawker type.
- II. The current number of vacant hawker pitches available for re-allocation, with a breakdown by location.
- III. It was mentioned under this Programme last year that the Department would issue new hawker licences. Please advise on the progress of work, the target this year as well as the manpower and expenditure to be involved.

Reply:

I. The information sought is provided as follows:

Remarks:

Including licences voluntarily surrendered by licensees for ex-gratia payment under the Hawker Assistance Scheme, licences temporarily or permanently surrendered for reconstruction works, and licences surrendered due to other reasons (licences surrendered due to death of licensees or transfer are not included).

- Including licences issued in the cases of succession to and transfer of hawker licence, newly issued tradesman licences and new licences collected under the Re-allocation of Vacant Fixed Hawker Pitches and Issue of New Licences scheme launched at the end of September 2019.
- II. The information sought is provided at Annex.
- The Food and Environmental Hygiene Department launched the scheme of III. Re-allocation of Fixed Hawker Pitches and Issue of New Licences at the end of September 2019. Under the scheme, 435 vacant fixed hawker pitches located at 7 districts will be open for application by persons who are interested in the hawking business and able to meet the required conditions. Successful applicants will operate at the pitches after a licence is granted. After launching the scheme, the Department received a total of 14 126 applications, of which 12 788 applicants were initially eligible. The Department conducted an open computer random sequencing cum manual ballot exercise to determine the priority order of applicants for pitch selection at the end of November 2019. Applicants have been invited for the selection of vacant pitches starting from early December. As at 29 February 2020, 349 applicants were invited for pitch selection. Among them, 236 have selected the pitches (77 of them have been granted with the fixed pitch hawker licence), 109 have given up pitch selection, and 4 were considered not eligible for the scheme. The pitch selection exercise is scheduled for completion in late April 2020. The work is mainly performed by 12 departmental staff at an estimated expenditure of \$8.04 million in 2020-21.
