Question:

In connection with household waste collection and management of public cleansing facilities, please advise this Committee on:

- 1. the annual expenditure on outsourcing the collection service for three-colour waste separation bins (three-colour bins) managed by the Department, the information on the contractors hired and the respective number of three-colour bins they handled in each of the past 3 years;
- 2. the whereabouts of the materials collected by the contractors in each of the past 3 years, with a breakdown by type (i.e. paper, metals and plastics), the quantities of materials (in kilograms) eventually recycled and the quantities of materials (in kilograms) ended up being disposed of in landfills;
- 3. the expenditure to be involved in outsourcing the collection service for three-colour bins in the coming year; and
- 4. the total number of complaints received by the Department against the contractors' frontline cleansing workers for disposal at will of recyclable materials as general waste in the past 3 years; details of the follow-up actions taken by the Department; and details of the surprise checks (if any) conducted by the Department to monitor the performance of the contractors in regard to the collection of recyclable materials. Besides, will the Department consider stipulating a minimum collection tonnage of clean recycling materials in the contracts? If yes, the details; if no, the reason(s).

Reply:

1. The names of the contractors engaged by the Department to provide recyclables collection services in the past 3 years and the respective contract values are tabulated below:

2. The recyclables collected by the contractors will be delivered to the relevant recyclers for proper handling, including processing them into recycled products or raw materials so that they can be exported or supplied to the local market. The general waste collected in the recyclables collection bins as well as the materials contaminated or unsuitable for recycling will be treated as general waste. The quantities of recyclables and other waste collected by the Department's contractors in the past 3 years are as follows:

- 3. The existing service contracts will expire on 31 August 2020. The expenditure required for the new contracts depends on the results of the public tender exercises to be conducted in due course.
- 4. The Department received 10 complaints against the contractors' improper disposal of recyclables in the past 3 years. As regards the follow-up actions on the complaints, in addition to routine inspections, the Department conducted surprise checks and took contract enforcement actions as appropriate. No improper disposal of recyclables was found in the follow-up inspections. Whether a minimum collection tonnage of

clean recycling materials should be stipulated in the service contracts depends on whether such a requirement is reasonable. The Department will take this into consideration when drawing up the terms and conditions of the new service contracts.
