1. The number of licensed factory canteens in the past 5 calendar years is as follows:

- 2. In the past 5 calendar years, the Food and Environmental Hygiene Department instituted 124 prosecutions against licensed factory canteens as the licence holders failed to comply with the licensing requirement on display of a notice reading "FACTORY EMPLOYEES OF THIS BUILDING ONLY" outside each entrance of the factory canteen and at conspicuous places of the seating accommodation and did not take corresponding measures to ensure that a factory canteen can only serve employees in the factory building where the canteen is situated.
- 3. to 5. Under the Food Business Regulation (Cap. 132X), a Factory Canteen Licence must be obtained from the Department for operation of food business in a factory building which involves the sale or supply of meals or drinks for consumption on the premises by persons employed in the factory building concerned. The Factory Canteen Licence was introduced to facilitate factory workers to take meals in the factory building. From the perspective of food safety as well as hygiene and fire safety of food premises, the Department is not inclined to issue General Restaurant Licences to canteens operating in factory buildings.
