## Question:

Permanent off-street refuse collection points (RCPs) are provided by the Food and Environmental Hygiene Department.

- a) What are the number of RCPs under the Department as at December 2019, the locations of RCPs which are provided with (i) changing facilities, (ii) common rooms, (iii) drinking facilities, (iv) mobile refuse compactors and (v) automatic refuse bin washing machines, and the area of common rooms (if any)?
- b) Does the Department have any plans to provide other RCPs with changing facilities, common rooms, drinking facilities, mobile refuse compactors and automatic refuse bin washing machines? What are the timetable for upgrading and providing the above facilities at individual RCPs and the expenditure involved in the 2020-21 financial year?

## Reply:

(a)&(b) The Food and Environmental Hygiene Department currently manages 161 permanent off-street refuse collection points (RCPs), 58 of which are provided with mobile refuse compactors (MRCs). All RCPs have drinking water facilities. Generally speaking, RCPs with roll call points are provided with changing rooms but not separate common rooms. For some RCPs without changing facilities owing to space constraints, the Department allows contractors to provide temporary changing and storage facilities where circumstances permit.

The Department has kick-started a pilot scheme to carry out improvement works at the roll call points in 24 RCPs for provision or enhancement of changing and storage facilities for staff. For newly built RCPs or when RCPs are refurbished, changing and storage facilities will be provided for in-house or contractors' staff if circumstances permit. MRCs will also be provided having regard to the operational needs and site situation of RCPs, but the Department has no plan to

introduce automatic refuse bin washing machines. There is no separate breakdown of the expenditure on provision of the above facilities. A breakdown of our RCPs provided with changing facilities, drinking facilities and MRCs is at Annex.
